












**Typical Transfer Characteristics** 









**Source-Drain Diode Forward Voltage**




Capacitance v Drain-Source Voltage




**Gate-Source Voltage v Gate Charge** 




**Basic Gate Charge Waveform**

**Gate Charge Test Circuit** 




**Switching Time Test Circuit**


