This device protects sensitive electronics from electrostatic discharge and surge lightning events, thereby safeguarding high-speed data interfaces and reducing EMI interference.

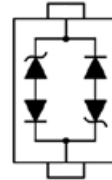

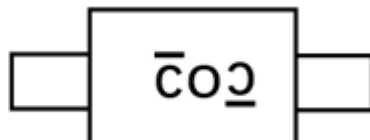

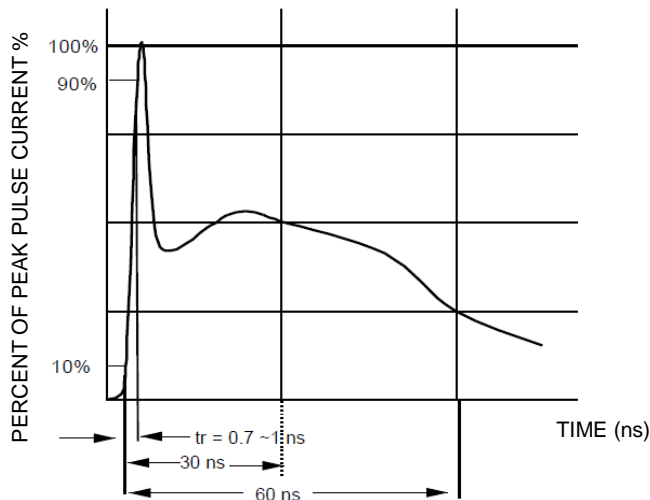


Figure 1. ESD Pulse Waveform According to IEC 61000-4-2

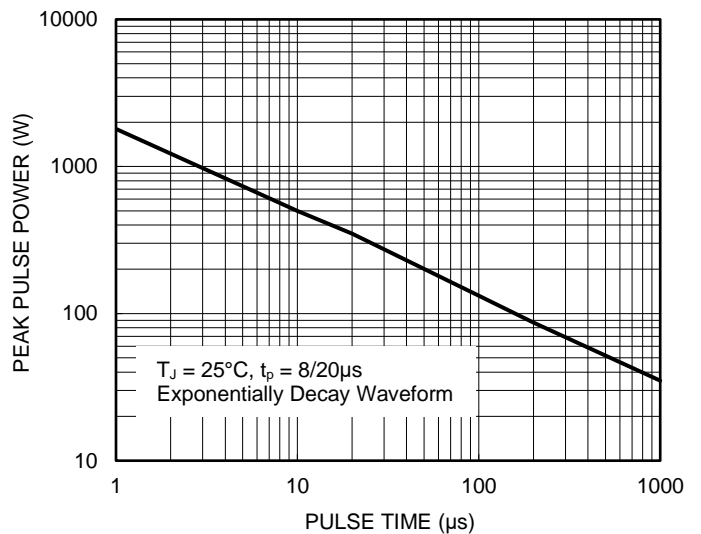


Figure 2. Power Dissipation vs. Pulse Time

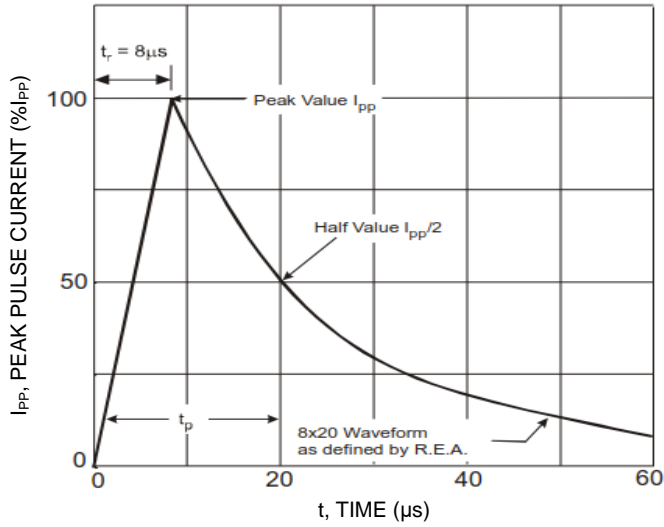


Figure 3. Typical 8 × 20µs Pulse Waveform

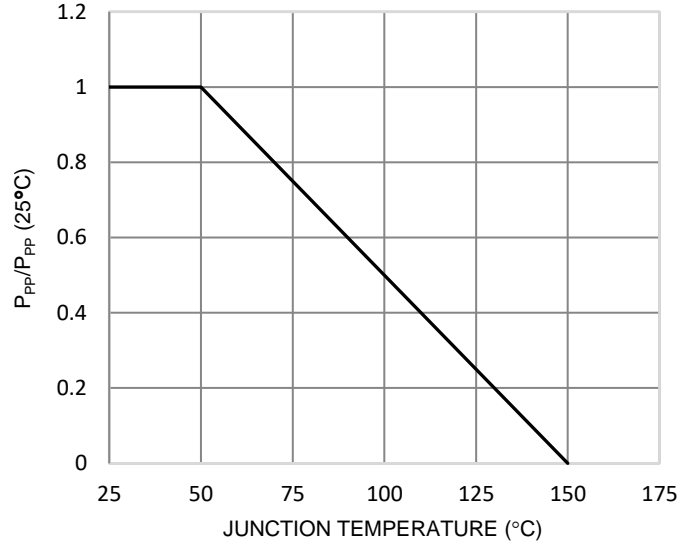


Figure 4. Peak Pulse Power vs. T_J

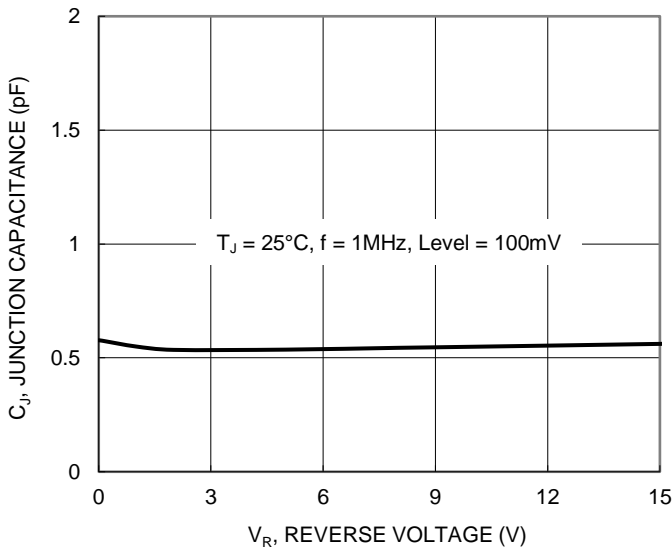


Figure 5. Typical Junction Capacitance

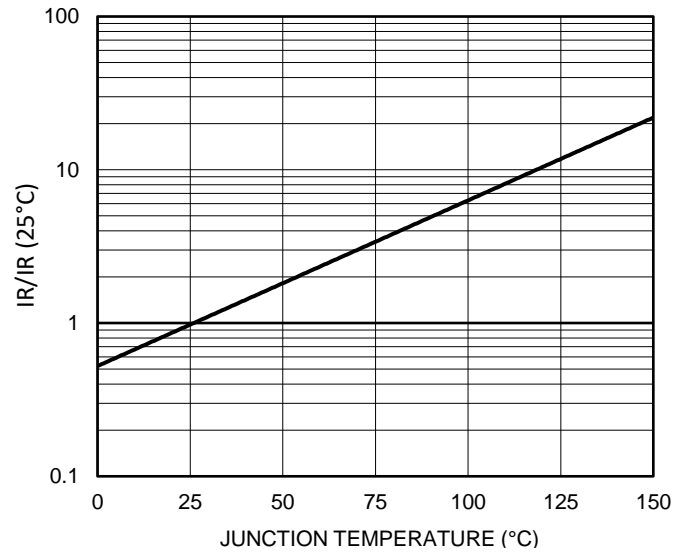


Figure 6. Reverse Leakage Current vs. T_J

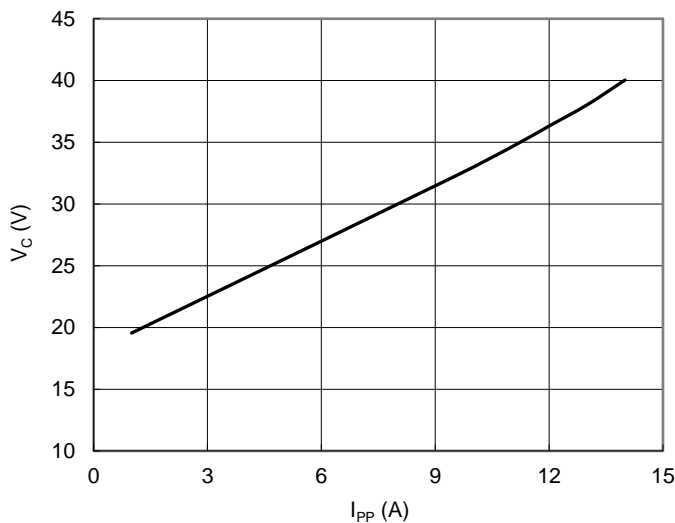


Figure 7. Typical Peak Clamping Voltage V_C vs. Peak Pulse Current I_{PP}

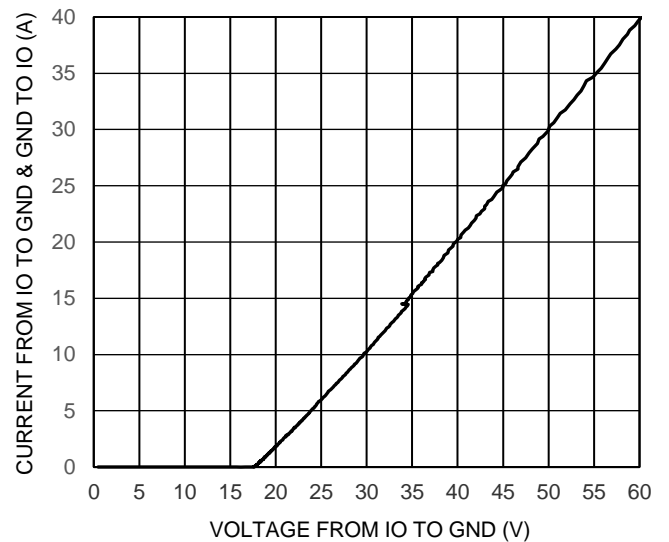
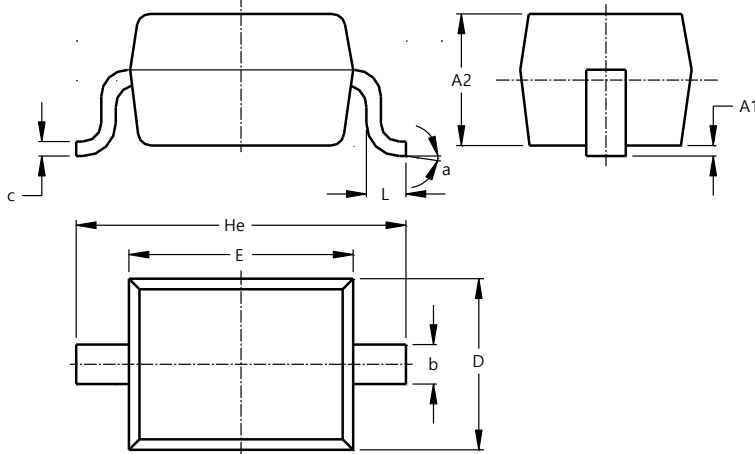


Figure 8. TLP Curve ($t_p = 100ns$)

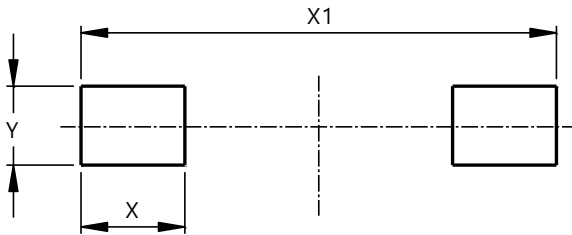
