






Top View Pinout





Fig. 2 Typical Transfer Characteristics




Fig. 4 Typical Drain-Source On-Resistance vs. Drain Current and Temperature




Fig. 6 On-Resistance Variation with Temperature










Fig. 7 Gate Threshold Variation vs. Ambient Temperature

Fig.12 SOA, Safe Operation Area







Fig.13 Transient Thermal Resistance


