







Figure 6. On-Resistance Variation with Temperature






Figure 7. Gate Threshold Variation vs. Ambient Temperature




Figure 9. Typical Junction Capacitance




Figure 11. Gate-Charge Characteristics




Figure 8. Diode Forward Voltage vs. Current




Figure 10. Typical Drain-Source Leakage Current vs. Voltage




Figure 12. Single-Pulse Avalanche Tested







Figure 13. Transient Thermal Response


