

### **QUADRUPLE 2-INPUT AND GATES**

## **Description**

The 74LVC08A provides four independent 2-input AND gates. The device is designed for operation with a power supply range of 1.65V to 5.5V. The inputs are tolerant to 5.5V allowing this device to be used in a mixed-voltage environment. The device is fully specified for partial power down applications using  $I_{\rm OFF}$ . The  $I_{\rm OFF}$  circuitry disables the output preventing damaging current backflow when the device is powered down.











**Voltage Waveform Propagation Delay Times Inverting and Non Inverting Outputs** 


