

#### ADJUSTABLE PRECISION SHUNT REGULATORS

### **Description**

The AZ431-B is a three-terminal adjustable shunt regulator with guaranteed thermal stability over a full operation range. It features sharp turn-on characteristics, low temperature coefficient and low output impedance, which make it ideal substitute for Zener diode in applications such as switching power supply, charger and other adjustable regulators.

The output voltage of AZ431-B can be set to any value between  $V_{\text{REF}}$  (2.5V) and the corresponding maximum cathode voltage.

The AZ431-B precision reference is offered in two voltage tolerance: 0.4% and 0.8%.

This IC is available in 4 packages: TO-92 (bulk or ammo packing), SOT-23, SOT-23-5 and SOT-89.





## **Typical Applications Circuit**






**Current Source or Current Limit** 




## **Typical Applications Circuit (Cont.)**








Test Circuit 6 for I<sub>OFF</sub>




#### Reference Voltage vs. Ambient Temperature




#### Cathode Current vs. Cathode Voltage




### Off-State Cathode Current vs. Ambient Temperature




#### Reference Current vs. Ambient Temperature



Cathode Current vs. Cathode Voltage




Ratio of Delta Reference Voltage to the Ratio of Delta Cathode Voltage









### Small Signal Voltage Gain vs. Frequency







### Reference Impedance vs. Frequency





### **Stability Boundary Conditions vs. Load Capacitance**









#### (1) Package Type: TO-92 (Bulk Packing)






#### (2) Package Type: TO-92 (Ammo Packing)






#### (3) Package Type: SOT-23






#### (4) Package Type: SOT-23-5
