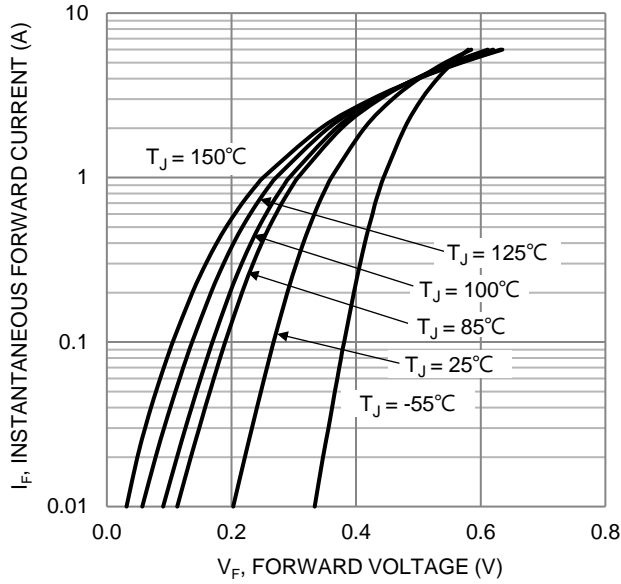


Figure 1. Typical Forward Characteristics

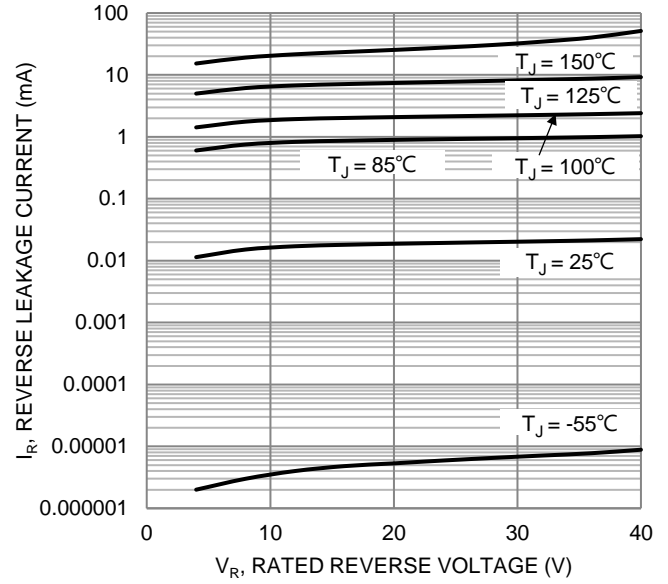


Figure 2. Typical Reverse Characteristics

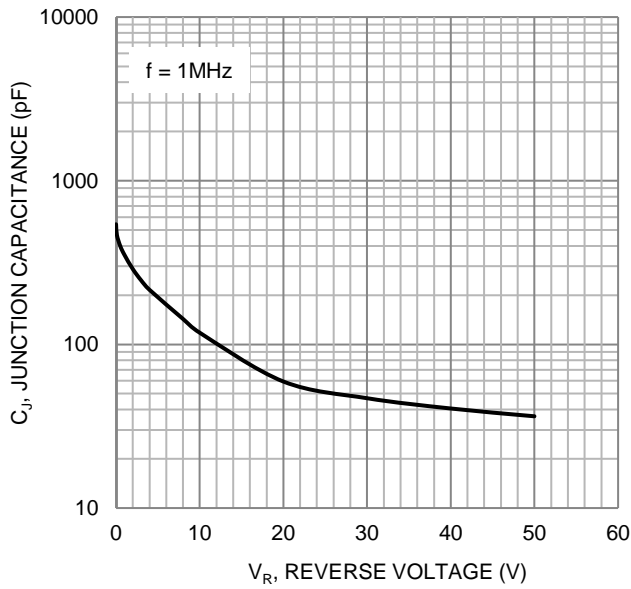


Figure 3. Junction Capacitance vs. Reverse

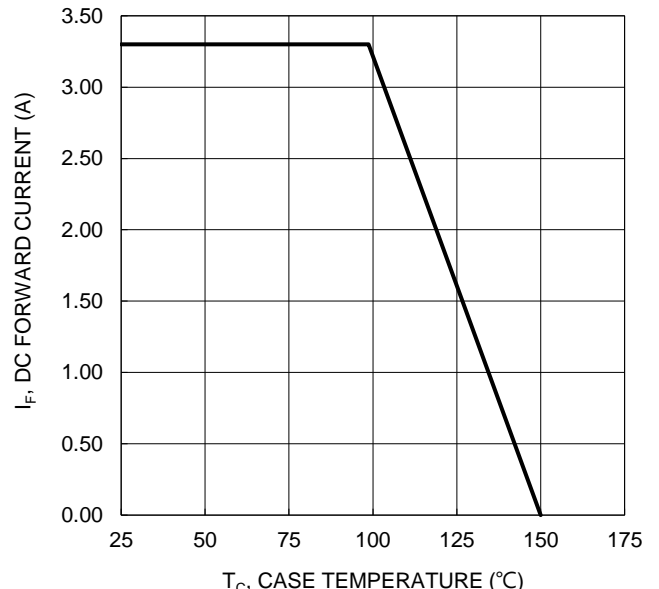
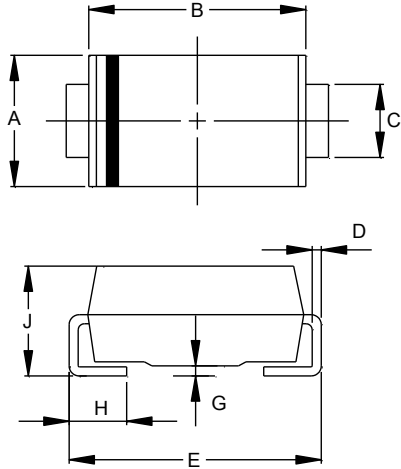


Figure 4. DC Forward Current Derating

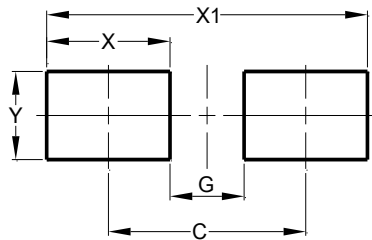
