




Figure 1. ESD Pulse Waveform According to IEC 61000-4-2

Figure 2. Power Dissipation Versus Pulse Time






Figure 3. Typical 8 x 20µs Pulse Waveform




Figure 4. Peak Pulse Power Versus TJ




Figure 5. Typical Junction Capacitance




Figure 6. Reverse Leakage Current Versus T<sub>J</sub>




Figure 7. Clamping Voltage Characteristics ( $t_P = 8/20\mu s$ )





Figure 8. TLP Curve ( $t_P = 100$ ns)


