




Fig. 1 Power Dissipation vs. Ambient Temperature (Note 3)




Fig. 3 Typical DC Current Gain vs. Collector Current





Fig 5. Typical Base-Emitter Turn-On Voltage vs. Collector Current






Fig. 4 Typical Collector-Emitter Saturation Voltage vs. Collector Current






Fig. 6 Typical Base-Emitter Saturation Voltage vs. Collector Current








