







Figure 7 Gate Threshold Variation vs. Ambient Temperature












Figure 10 Typical Gate-Source Leakage Current vs. Voltage



-V<sub>DS</sub>, DRAIN-SOURCE VOLTAGE (V) Figure 12 SOA, Safe Operation Area






