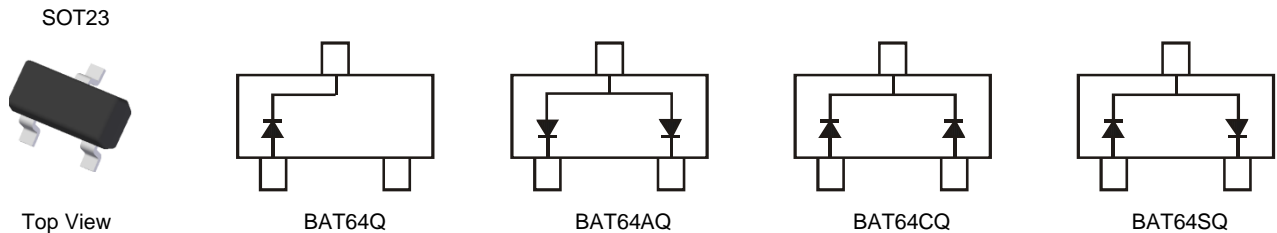

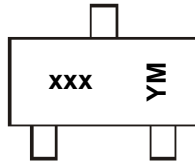

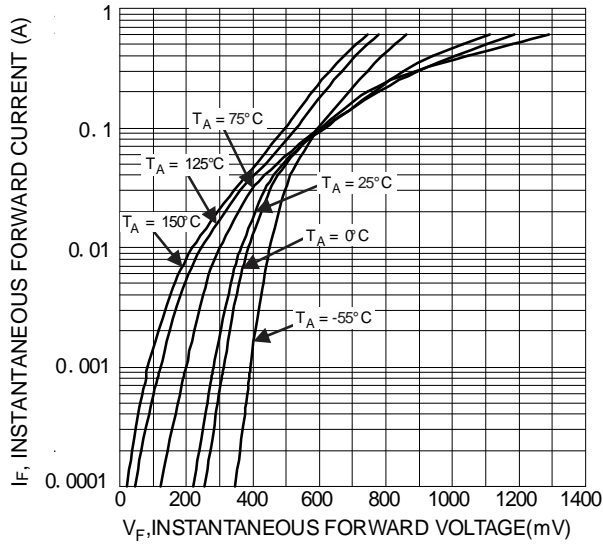


Figure 1 Typical Forward Characteristics

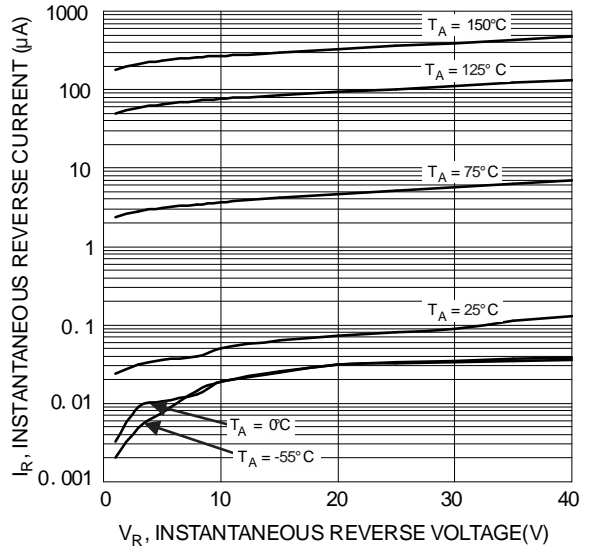


Figure 2 Typical Reverse Characteristics

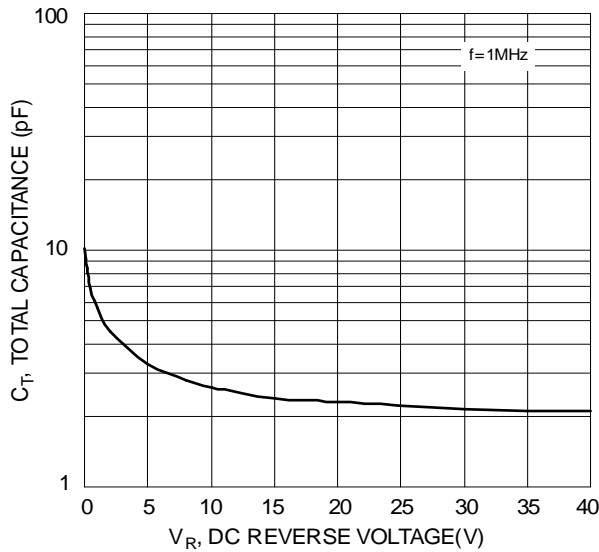


Figure 3 Total Capacitance vs. Reverse Voltage

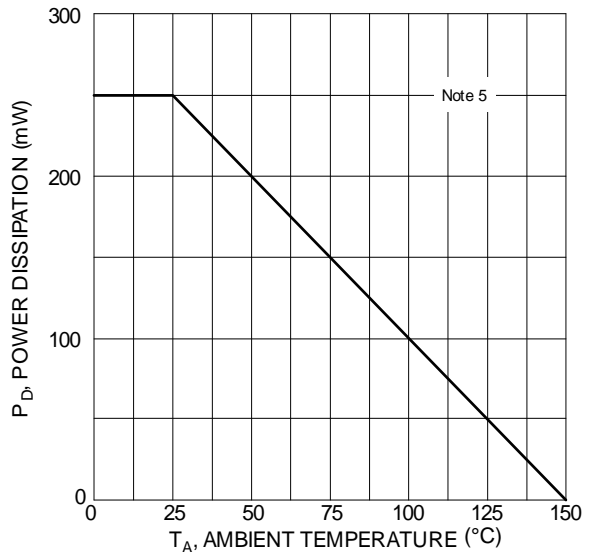


Figure 4 Power Derating Curve

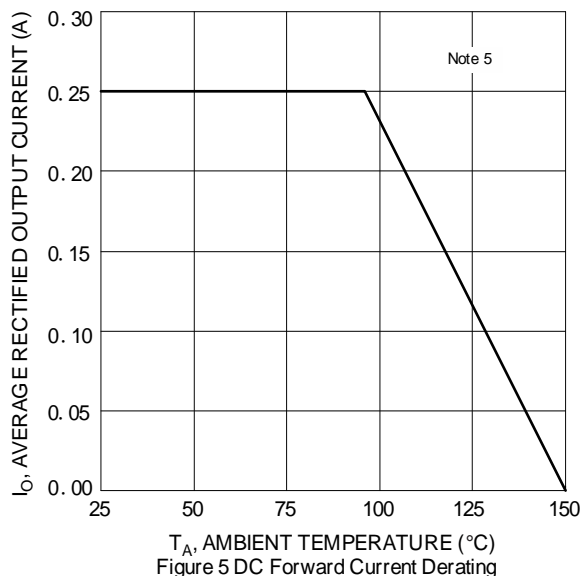
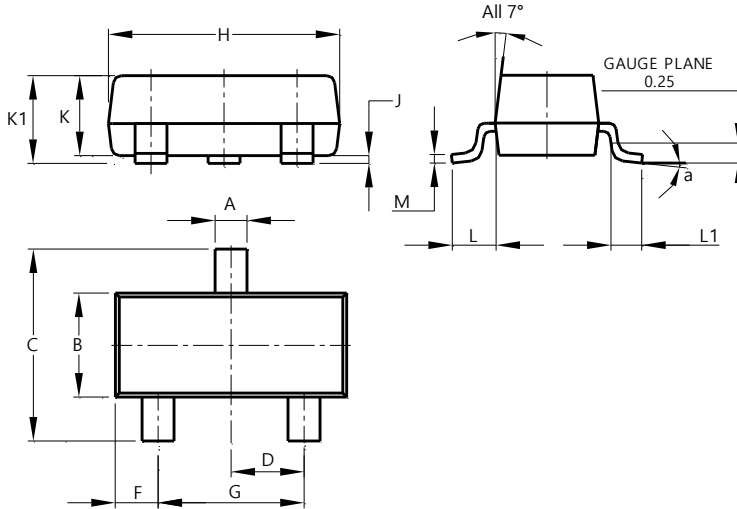


Figure 5 DC Forward Current Derating

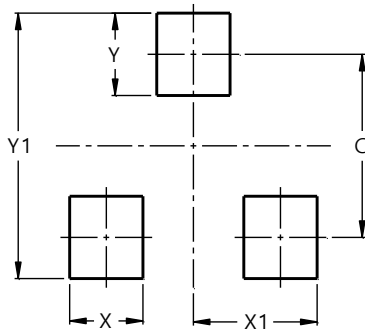
