






Fig. 1 Power Dissipation vs. Ambient Temperature (Note 3)








Fig. 2 Typical Collector Current vs. Collector-Emitter Voltage




Fig. 4 Typical Collector-Emitter Saturation Voltage vs. Collector Current




Fig. 6 Typical Base-Emitter Saturation Voltage vs. Collector Current




