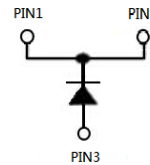
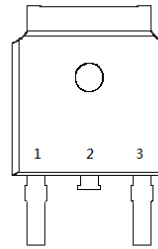

FIG.1 FORWARD CURRENT DERATING CURVE

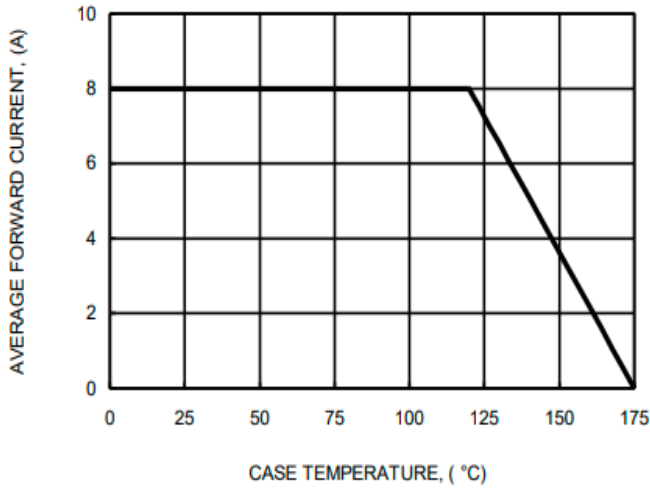


FIG.2 NON-REPETITIVE PEAK SURGE FORWARD CURRENT

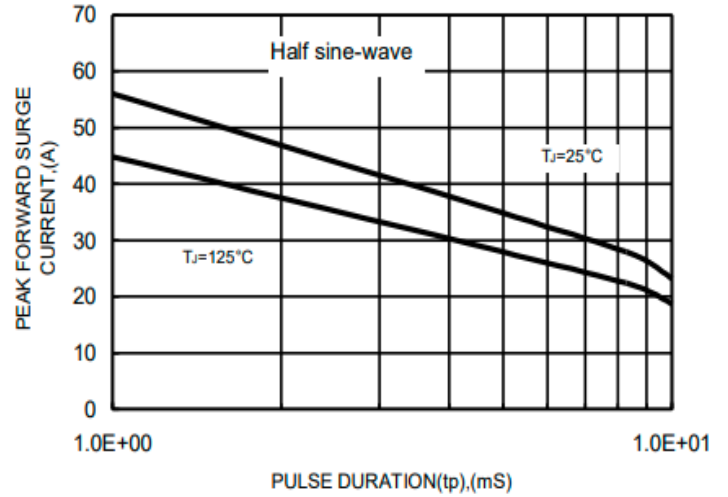


FIG.3 TYPICAL FORWARD CHARACTERISTICS

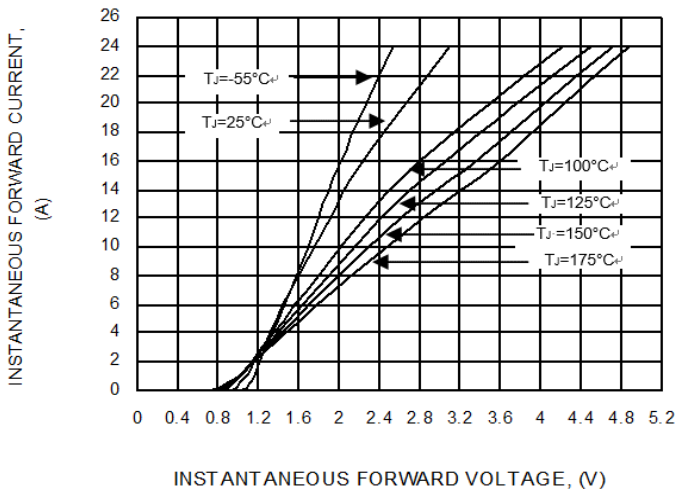


FIG.4 TYPICAL JUNCTION CAPACITANCE

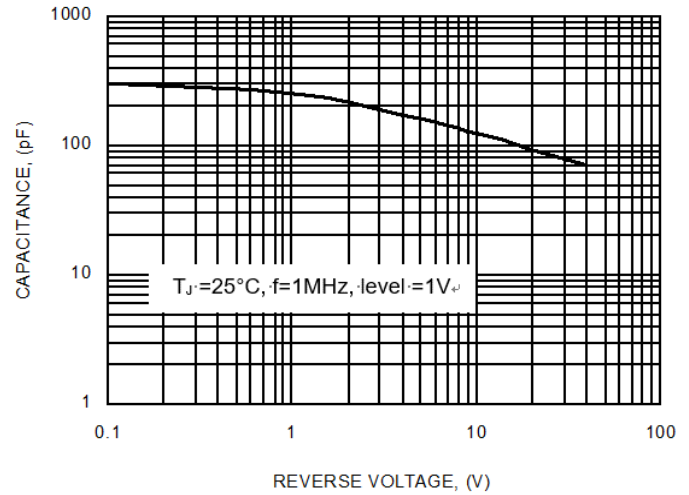


FIG.5 TYPICAL REVERSE CHARACTERISTICS

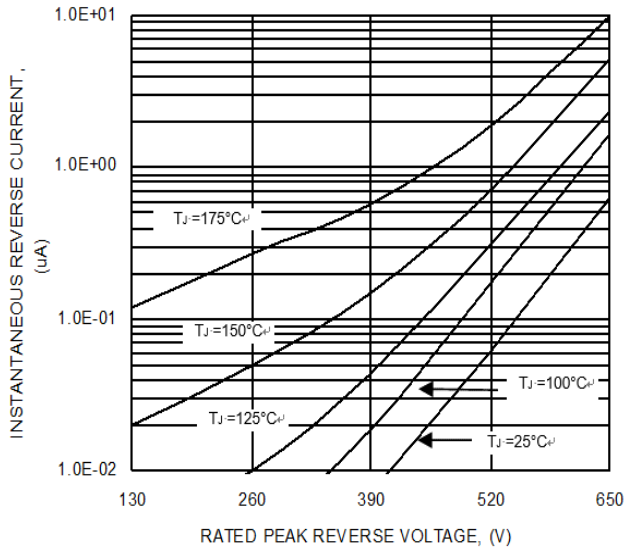
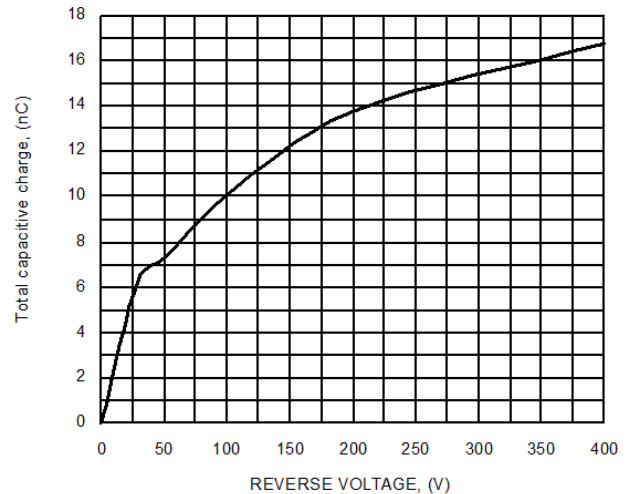
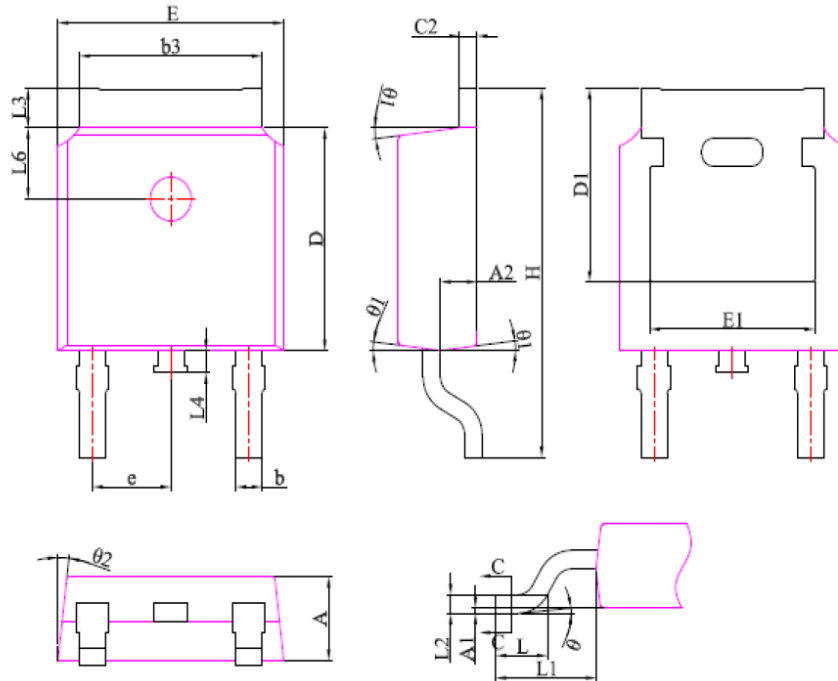


FIG.6 TYPICAL CAPACITIVE CHARGES

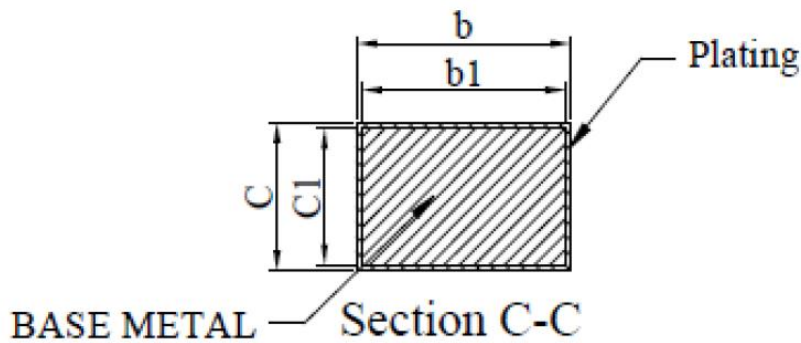

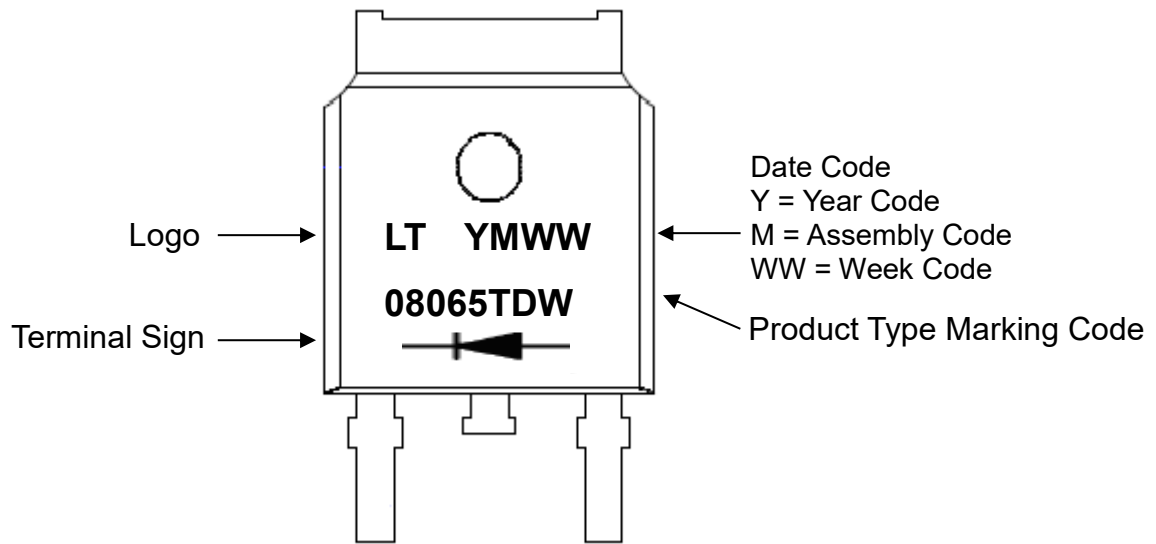
